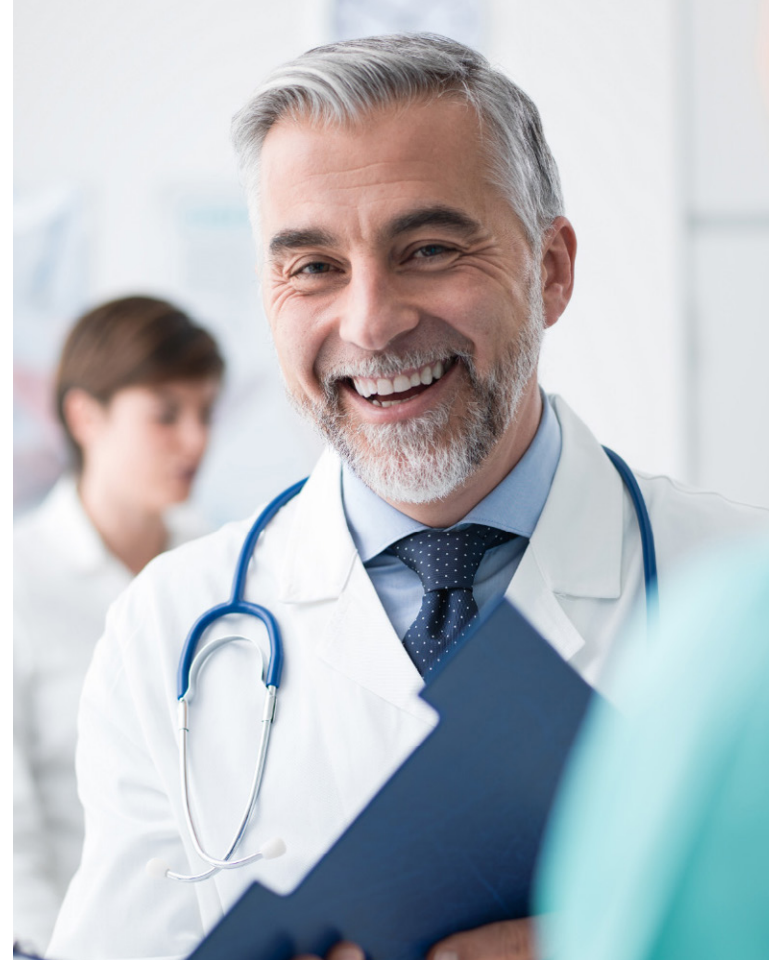
## Your health and safety

# MOBILE AMBULATORY CARE UNIT

We arrange in-person visits to your company in an efficient and timely manner.



Each of our Mobile Clinics is equipped with 2 internal clinics, soundproof booths and toilets, in which to perform medical-diagnostic services in-person at the partner company, thereby optimising the organisation and execution of visits.

Our mobile units have a self-power system with a 24-hour runtime without external power and can be placed anywhere, even on the most difficult construction sites.

This solution is suitable for all companies that need an itinerant outdoor venue that enables timely and functional execution of health care services.

### TYPE A - The latest generation



Ideal for conducting cardiology, orthopedic, neurology, ENT, and vascular specialist examinations, this unit consists of two internal compartments that allow for the smooth performance of examinations and exams. One of the two internal rooms can be used as an office or waiting room, and thanks to the two auxiliary generators,

it has an autonomy of 48 hours. Benefits include indoor air conditioning and supplementary heating system for temperatures down to -25C° with the silent cab that can transform into a cabinet for urine specimen collection. The piston-driven stabilization system allows leveling even in the roughest terrain.

### TYPE B - The queen of comfort



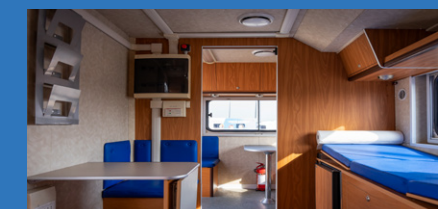
This mobile unit is best suited for examinations requiring basic diagnostics. Functional for taking blood-urinary samples and performing basic ECGs, it consists of two internal outpatient clinics with a silent cabin that can transform into a urinary sampling cabinet.

It is also equipped with an air conditioning system, ground heating, auxiliary generator with up to 24-hour autonomy and a piston stabilization system that allows leveling even in the roughest terrain.

### TYPE C - The multi-purpose



Mobile unit equipped with 3 distinct environments suitable for the simultaneous activity of 3 healthcare professionals (1 doctor + 2 nurses) for carrying out medical examinations, supplementary instrumental tests, and blood draws. It is also equipped with a silent cabin located in a separate space that allows for audiometric

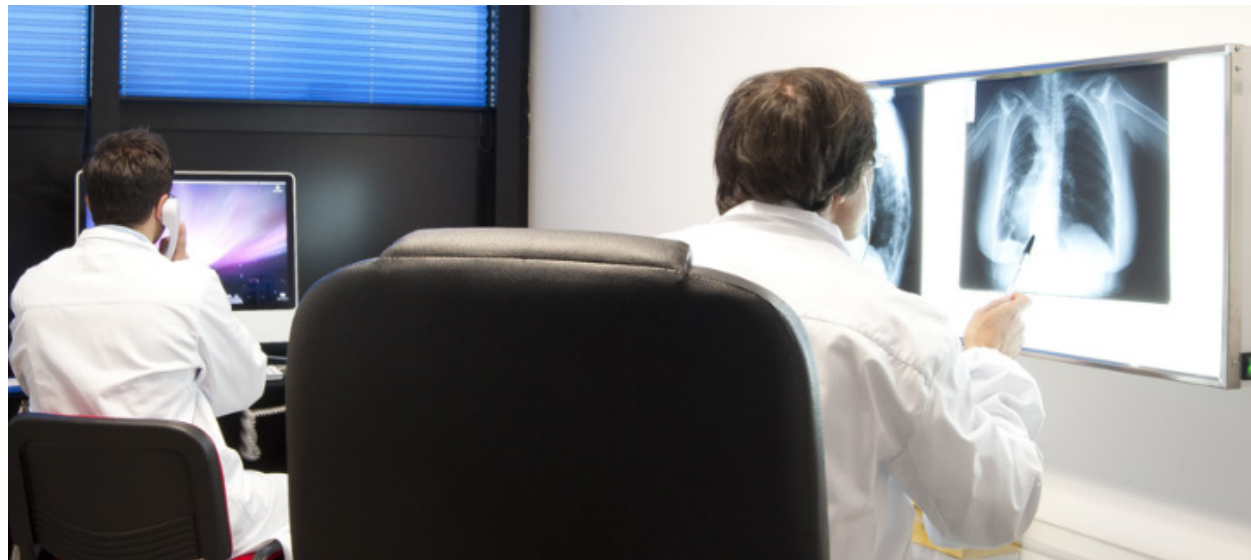
exams to be performed in an even more soundproof and high-performing environment. Additionally, this mobile unit is equipped with air conditioning, an auxiliary power generator with a autonomy of up to 24 hours, and a piston stabilization system that allows for leveling even on the most rugged terrain.

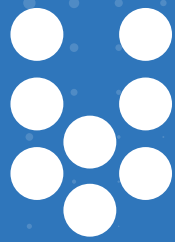
### SiProm management software

### With SiProm, you can:

- Perform employee searches and extract the list in csv (Excel) format.
- Access each employee's file, which contains biographical and career details (matriculation, home office, supervisor, type of employment, date of hire) as well as specifics on the medical examination.
- Download employee ratings upon upload by the health surveillance facility.
- Download the inspection forms and appointments of the medical officers
- Track employee visit schedules by time frames and the last visits completed.
- Download the suitability form of the last visit as a PDF and the document on inspection, company visits and appointment of the medical officer.

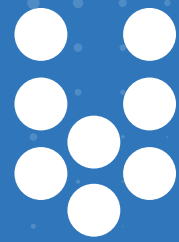

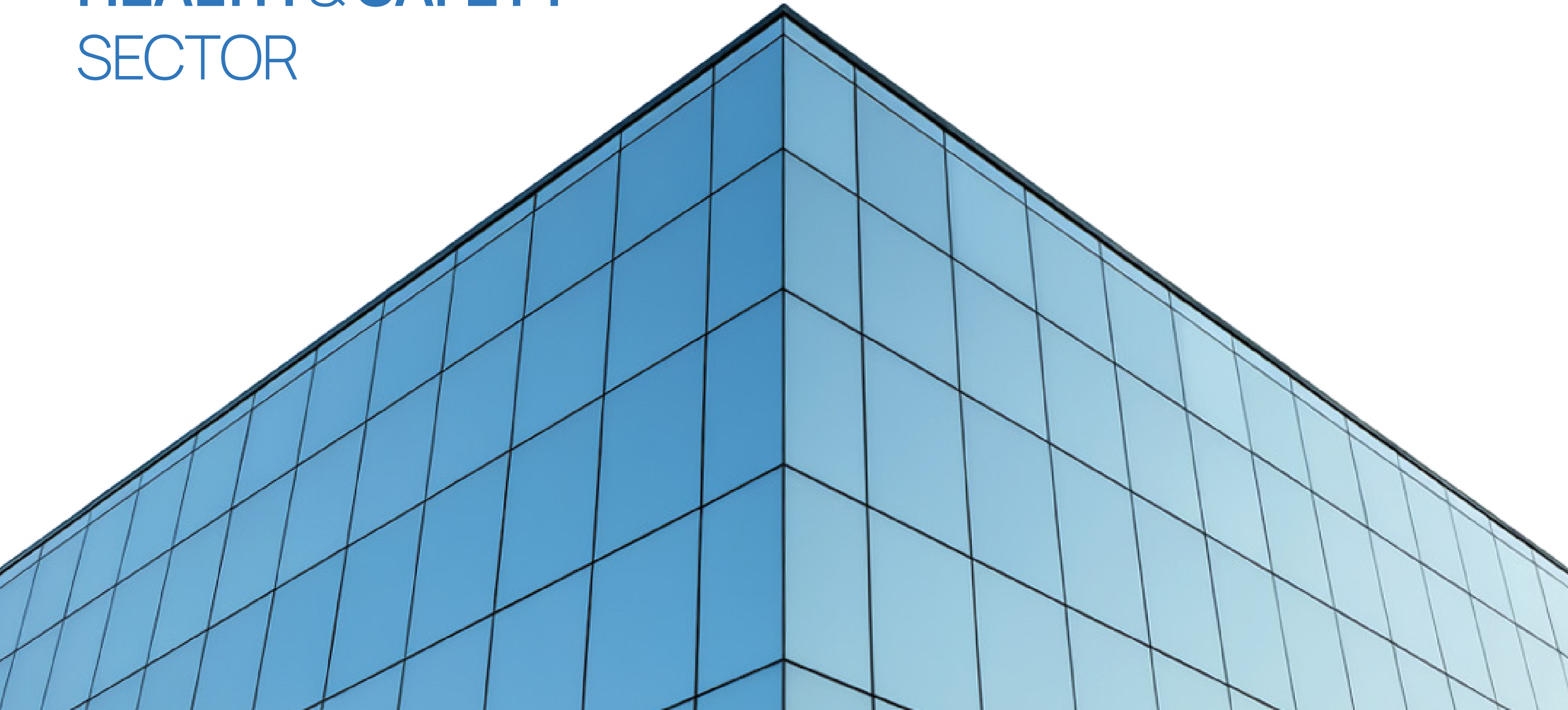
